

CMRP Exam Scholarship Application

You are a health care supply chain professional – it's time to recognize your expertise and get certified through the AHA Certification Center to gain the recognition you deserve! Up to 50 AHRMM members who apply for a CMRP Scholarship between October 4, 2018, and October 18, 2018 will receive a voucher for the full CMRP exam fee. This is a limited-time, exclusive offer only available to active AHRMM members who meet the eligibility requirements. *Note: This offer does not apply to any existing exam applications or to members who are currently certified. Exam applications already submitted to AMP are not eligible for this scholarship.*

QUALIFICATIONS:

- Applicants must be active AHRMM members in good standing with the Association.
- Applicants may not have received a CMRP Scholarship in the past 3 years (since 1/31/2015).
- Applicants may not have received any other AHRMM scholarships within the last year, including the AHRMM18 scholarship.
- Applicants must meet the exam eligibility requirements listed below.

INSTRUCTIONS:

1. Complete this Scholarship Application and return it by email by **October 18, 2018** to AHRMM at ahrmm@aha.org.
2. Applicants will be notified no later than October 29, 2018. **Do not** apply for the exam, schedule an exam, or contact AMP (the exam administrator) during this time.
3. Successful scholarship applicants will receive a voucher code for the exam fee that will expire in December 2018. Recipients must submit this voucher with the CMRP exam application to AMP before the voucher expires.
4. AMP will notify applicants following receipt and processing of the voucher. *AHRMM recommends that scholarship applicants be prepared to take the exam before December 31, 2018. Those interested in taking the exam at a later date are encouraged to consider applying for a scholarship next year.*

ELIGIBILITY REQUIREMENTS

A candidate must fulfill one (1) of the following requirements for education/healthcare experience. **Check the one that applies.**

- Baccalaureate degree from an accredited college or university plus three (3) years of associated healthcare resource and materials management* experience.
- Associate degree or equivalent from an accredited college or university plus five (5) years of associated healthcare resource and materials management* experience.
- High school diploma or equivalent plus seven (7) years of associated healthcare resource and materials management* experience.

* This includes persons who are involved in the materials functions of healthcare facilities; or are active in the healthcare materials supply chain, including manufacturers, vendors, distributors, consultants and employees of group purchasing organizations.
