- Applicants must meet the eligibility requirements outlined in the [CMRP Renewal Application](#). (Please note that a certificant who fails to meet the certification renewal requirements can only regain certification through re-taking and passing the CMRP Examination.)

2. Applicants will be notified no later than October 29, 2018. **Do not** apply for certification renewal during this time.
