



Supply Chain Resource Council (SCRC) Report

August 29, 2022 Meeting

Executive Summary

Semiconductors, Tyvek and resin shortages constitute the primary raw materials responsible for a number of finished goods/ supply shortages. Aside from this, the news coming out of this call was upbeat with a handful of good news concerning contrast media (supplies are improving); infant formula (no shortages reported); and medical gases (no CO2 allocations imposed on hospitals located in the Northeast and hospital members in general, or current impact to Lab operations or MRI utilization due to helium shortages).

Most concerning were shortages of single use non-sterile blood pressure cuffs, sterile prefilled flush syringes, and BD procedure trays. Details are reported below in the full Council report.

▲ Field Updates

- Medical Gasses were discussed, specifically helium and CO2 availability. Hospital members reported no impact, while medical device manufacturers reported that "helium supplies were tight and challenging." The SCRC will keep this as a running agenda item in the event product availability begins to impact the patient care setting. Summary information is listed below.
 - a. FEMA Medical Gases Playbook will be available
 - i. Shared with SCRC members. Attached for ease of reference.
 - b. CO2 force majeure notices and allocations going into effect, primarily in the Northeast
 - i. SCRC members indicated they did not receive force majeure notices and have not been placed on allocations for CO2.
 - c. Helium shortages
 - i. Impact to MRIs
 - 1. SCRC members indicated the helium shortage had not impacted MRI utilization.
 - ii. Medical labs/facilities are being prioritized
 - 1. SCRC members indicated the helium shortage had not impacted lab operations.
- 2. Lobel Lurie shared a Customer Letter from Nestle Health Science dated August 16th regarding short supplies of their Compleat® Pediatric Organic Blends Chicken Garden Blend. The product is expected to be out of stock for approximately 4 weeks due to increased demand and ingredient supply chain challenges. Nestle stated they have sufficient inventory on hand of the preferred substitute product, Compleat® Pediatric Organic Blends Plant-Based Blend, to cover this stock out.

▲ Supply Shortages and Disruptions

1. Contrast Media

Several SCRC members indicated that availability and on-hand inventories of contrast media were improving.
 Moving forward, supply chain executives plan to incorporate selected conservation strategies employed during
 the height of the shortage into their operational practices. Stringent supply and utilization practices will be
 incorporated into disaster planning and preparedness strategies should a similar shortage happen again in the
 future.

2. Formula Update?

• There were no formula shortages reported, nor was anxiety or discomfort from hospitals or community members conveyed regarding the purchase and use of imported formulas.

3. SPD Product Shortages

- On-hand inventory levels and product availability challenges with single-use, reusable non-sterile blood pressure
 cuffs was expressed. Conversations with manufacturer's products teams revealed that non-sterile cuffs are
 being sterilized as a part of the reprocessing protocol and associated with the product's 510K approval, which is
 compounding the issue of product availability.
- SCRC members discussed the opportunity to raise awareness with the FDA regarding the product shortage and sterilization protocols, including expanding the number of uses for the cuffs before returning to the manufacturer for reprocessing, or reprocessing the cuffs onsite.
- Further reduction in inventory and product availability places the health care organization at risk; "if the supplier
 can only fill at 60%, I have to then decide as a facility, do I reprocess and or reuse an approved single-use device
 to continue procedures, or do I cancel procedures where I can? The reality is with trauma and other things, you
 cannot cancel those."

▲ SCRC Watch List — Raising awareness to growing supply shortages

- Sterile Prefilled Flush Syringes. With Cardinal exiting the market, there is a small number of suppliers out there at this time, however most of the suppliers trying to enter the market space are OUS, the product is prefilled, not sterile prefilled, and the product is priced approximately 300% higher than existing product pricing. BD has increased their production and it's believed they are starting to bring product in from Europe to help.
- BD procedure trays. BD is exiting the market for procedure trays including lumbar puncture, myelogram, cervical and circumcision trays. BD is projecting remaining inventory to be exhausted by the end of October. Some distributors and manufacturers are indicating that they are unable to absorb the business. Consequently, one health system is exploring the purchase of the tray components and assembling them in-house.
- Needles and Syringes. Hypodermic, 25 gauge, 1 1/2 inches beveled syringe needles and Spinal needles were
 raised by the group as items of concern.
